# Ongoing Efficiency Gains

## Energy & Carbon Metrics



### Electricity

- 69% of purchased electricity is renewable.



### Natural Gas

- Gas use remains a significant emissions source, no renewable supply available.
- Reduction measures: improved heat control air circulation



### Emissions

- Verified annual GHG emissions for 2025: 655 tCO<sub>2</sub>
- Achieved reduction target of 4.5% as set under ISO 14001 objectives.

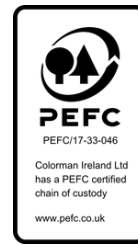
## Certification & External Verification
